## COVID-19 case numbers

- As of **15 September 2020**, there have been **659** confirmed cases of COVID-19 notified in Western Australia (WA) and **34 historical cases**. **646** people have recovered.
- To date **384,601** COVID-19 tests have been conducted in WA.

## Message of the week

### COVID-19 prevention measures for the workplace

Although workplaces may be exempt from the 2m<sup>2</sup> rule under the [Closure and Restriction \(Limit the Spread\) Direction \(No5\)](#), WA Health still recommends physical distancing wherever possible. ## Community

### DETECT Borders program

New weekly testing of WA border and hotel quarantine workers will run from now until the end of November. This program offers free, voluntary testing for frontline workers at COVID clinics in the metro and regional areas and aims to detect and prevent or limit community transmission of COVID-19. Some testing will be facilitated in affected workplaces to maximise participation.

People who fit the criteria for asymptomatic testing do not need to self-isolate after testing and can resume normal activities immediately. Negative results will be sent via SMS. Anyone who tests positive will be followed up in line with existing public health procedures.

People who are eligible for this testing include adult workers who display **no symptoms** of COVID-19 working at:

#### State Health Incident Control Centre (SHICC) quarantine hotels

- Hotel employees (including contractors)
- Security staff working at the hotel
- Health staff
- Drivers of transport of quarantine guests
- WA Police
- Others, such as Australian Defence Force.

#### Perth Airport

Workers on-site at Perth Airport in areas through which arriving passengers (or their baggage) transit including:

- Perth Airport or airline staff
- WA Police
- Security
- Federal agencies
- Drivers of hotel quarantine buses.

#### Sea ports

Any employee or contractor involved in any function of a sea port that involves close contact with people arriving from overseas.

#### Eucla and Kununurra border crossings

Any employee or contractor involved in any function at Eucla or Kununurra border crossings that requires close contact with people arriving from interstate.

Any other community member who has symptoms of COVID-19, even if mild, is encouraged to get tested so we can catch cases before they spread.

## Outbreak planning

The Public Health Emergency Operation Centre (PHEOC) continues to plan for, and refine, the public health response for COVID-19 outbreaks. Planning has involved site visits to high risk settings such as Aged Care Facilities, Abattoirs, Correction Facilities and Food Distribution Centres. In addition, desktop scenarios are being conducted to assess current planning and public health response against hypothetical outbreak situations in both metropolitan and regional settings.

## GeneXpert rollout complete

WA now has 14 GeneXpert machines deployed around the state. These machines can be used for the rapid testing of COVID-19. The rollout of these machines is particularly important for regional WA, as samples from these areas would normally involve longer transport times, delaying COVID-19 results. The last three sites to go live included Esperance, Northam and Carnarvon.

## Regular testing of interstate freight drivers

Any truck driver entering WA is required to present for testing every 7 days while in WA (up until they have been in WA for 14 days). See our [Transport, Freight and Logistics Directions FAQs](#).

## Testing

### General population [testing criteria](#) (updated 14 September 2020)

Any person may be tested if they have any one of the following clinical criteria: fever ( $\geq 37.5^{\circ}\text{C}$ ) OR history of fever (e.g. night sweats, chills), without a known source **OR** an acute respiratory infection (e.g. shortness of breath, cough, sore throat), **OR** acute loss of smell or taste.
